**Metropolis of New Jersey Greek Folk Dance Festival 2015  
Code of Conduct Form**

With my signature, I acknowledge and agree to abide by the FDF Code of Conduct and agree to accept the consequences for actions that violate the rules of conduct as outlined below:

- Use of vulgar language and loud noises are strictly forbidden.
- Use of Alcohol by underage participants at the FDF, in hotel rooms, or any other related FDF events is strictly forbidden.
- Smoking by underage participants at any FDF related event is prohibited. Smoking by adults is prohibited in the performance areas.
- Illegal drug use is prohibited at all times by anyone involved in the FDF.
- Damage to personal or public property of any kind is strictly prohibited and is the sole responsibility and liability of the person or persons involved.
- Any disrespect shown to another person whether dancer or observer is strictly prohibited
- Room visitations involving our youth (mixed company) is strongly discouraged.

**\*Violation of any of the above items shall result in disqualification, as well as possible eviction from the FDF event and hotel.**

***Probation***

For those who break the rules of conduct, whether dancer, parent, or chaperone or non-dancer friends will have their whole group immediately put on probation and risk the possibility of being evicted from the event as well as withdrawal of any awards. The group will be on probation for the remainder of the weekend. Any additional rule infractions while on probation will result in immediate disqualification.

***Disqualification***

A second offense by anyone directly or indirectly associated with a dance group on probation will result in that group's immediate disqualification. Disqualification means that the dance group will be allowed to finish the competition/performance but will not be eligible for an award. In addition, the community's Priest and Parish Council will receive a copy of the reprimand. Further infraction of the rules by anyone associated with a disqualified group(s) during the remainder of the FDF will result in immediate ejection of those individuals from the FDF, the hotel, and any other place the FDF has contracted with for this event.

***Code of Conduct Policy Statement Waiver***

Dance Competition Rules**

***Dance Group Division and Categories***

**DIVISION I** - Division I groups are **COMPETITIVE** groups and consist of two categories. They are: Senior (ages 15-18) and Intermediate (ages 13-15).

**DIVISION II** - Division II groups are **COMPETITIVE** groups and consist of two categories. They are: Junior (ages 11-13) and Primary (ages 8-10).

**DIVISION III** - Division III groups are **NON-COMPETITIVE/Pre-primary**. (These groups are for dancers' ages 8 years old and under).

**\*\*\* YOUNG ADULT DIVISION** – Young Adult groups are **COMPETITIVE** groups which only dance **ONCE** on Saturday. These groups are for dancers aged 18 and older (or out of High School). Instructors are permitted to dance with the young adult division groups.  
**\*\*\*ALL DANCERS WILL BE LIMITED TO DANCING WITH ONE SPECIFIC GROUP. (NO SWITCHING GROUPS OR DANCING WITH TWO SEPARATE GROUPS IS PERMITTED).**

All groups will receive critique guidelines on how their individual group performs. They will not be compared to other groups. Only DIVISIONS I & II & Young Adult groups will compete and will be qualified to receive **FIRST, SECOND, or THIRD** place awards. There will also be a Best Costume Award for each category; Primary, Junior, Intermediate, Senior, & Young Adult.

***Performance Areas***

The performances will take place at the Annapolis High School on Saturday, January 17, and Sunday, January 18, 2015. The size of the stage is approximately 60 feet wide and 25 feet deep. Directors please note \* **NO COACHING ALLOWED DURING PERFORMANCE.** INSTRUCTORS ARE NOT ALLOWED ON STAGE AS DANCERS OR SINGERS (EXCEPT FOR YOUNG ADULTS). SINGING AND LIVE MUSIC IS ALLOWED, BUT NOT BY INSTRUCTORS ON STAGE (THIS IS CONSIDERED COACHING AND THE GROUP WILL BE PENALIZED).

***Special Requests***

Please submit to the Competition Chairperson your requests (in writing) for how you want your dance groups to start performing on stage. For example, do you want your dance group to dance onto the stage at the start of the music, or do you want them to walk on, line up first and then start the CD? Also, if using live musicians please report the number of chairs and microphones you will need on stage for the musicians. Each group is to provide their own props. Special requests are due December 15, 2014.

***Music***

All music must be recorded on high quality Compact Discs (CD's). There is no assurance that your music will sound professional unless this is done. \*\*The F.D.F. Performance Chairperson will not be held responsible for the quality of your performance music.

\* Do not record more than one dance group performance on a single CD. Each parish must submit two (2) CD's per group to the Performance Chairperson. Once your CD's have been submitted they will not be returned for any reason. If you intend on practicing during the day we suggest that you bring a set of CD's and a player for your own use. It is strongly suggested that practices do not occur during scheduled meal hours in as much as meal times cannot be extended to accommodate the tardy.

### ***Time Limits***

The maximum performance time **on stage** is ten (10) minutes for each group (8 minutes for Division III groups) during the Semi-Final Round and twelve (12) minutes for each group during the Final Round (Division III will not perform in final round). The Young Adult division has 12 minutes allotted in one Saturday performance. Any dance group exceeding the maximum time allotted for each round of competition will be penalized as follows:

- Fifteen seconds over maximum time allotted – penalty of 10% subtracted from total cumulative score.

Our sound technicians will be instructed to keep the CD running from the moment it starts until the moment the dance group leaves the dance floor. They WILL NOT start and stop the CD for your group.

### ***Disciplinary Action***

Disorderly conduct of any kind (i.e.: excessive noise, use of vulgar language, running through the facility, throwing of food...etc.) WILL NOT BE TOLERATED and may result in an automatic disqualification of person(s) involved without refund. It is imperative that order is maintained at all times. All F.D.F. participants are expected to conduct themselves in accordance with the F.D.F. bylaw rules and the Conduct Policy Statement as described in the Behavioral Policy Statement and on the bottom of the Individual Participant Registration Form.

### ***Awards***

There will be First (GOLD), Second (SILVER), and Third (BRONZE) place awards for each level in Divisions I, Division II, and Young Adult groups, plus Best Costume awards for each category.

**Definitions of Judging Format:**

All dance groups will be critiqued on how they as an individual group perform. Only Divisions I + II groups will compete.

**A. Ethnic Quality**

THIS REFERS TO THE AUTHENTIC CHARACTER OF THE DANCE STYLE AND STEPS. DIFFERENT REGIONS WITHIN GREECE HAVE VASTLY DIFFERING MUSIC AND DANCES; THIS DIVERSITY SHOULD BE RECOGNIZED AND REPRESENTED, SUCH AS THE MUSICAL AND STYLISTIC VARIATION BETWEEN THE REGIONS OF CRETE AND EPIRUS.

1. DANCE STYLING
  - A. POSTURE
  - B. Demeanor of the group as a whole
  - C. ACCURACY OF THE REGIONAL DANCE STYLE
2. DANCE STEPS/PATTERNS
  - A. ACCURACY OF THE REGIONAL DANCE STEP AND STYLE.

**B. Stage Presence**

1. ORIENTATION:

ORIENTATION REFERS TO THE CHOREOGRAPHY, SPACE USAGE AND FOCUS OF THE DANCERS AND THE PERFORMANCE AS A WHOLE.

2. BALANCE:

REASONABLY EVEN LEVEL OF CAPABILITY EXHIBITED BY ALL THE DANCERS. A GROUP IS NOT IN BALANCE IF, FOR EXAMPLE A FEW OUTSTANDING DANCERS CARRY THE PERFORMANCE.

3. "KEFI" OR SPIRIT OF EXPRESSION:

REFERS TO THE APPROPRIATENESS OF THE GROUP'S ATTITUDE, FEELING AND PROJECTION, WHETHER JOYOUS OR SERIOUS, IN ACCORDANCE WITH THE AUTHENTIC CHARACTER OF THE DANCE AND THE PURPOSE IT SERVED IN GREEK VILLAGE SOCIETY.

**C. Precision**

THIS REFERS TO WHETHER THE DANCERS ARE IN SYNCHRONIZATION "ON BEAT" WITH THE TEMPO AND RHYTHM OF THE MUSIC AND THE PRECISION OF EXECUTING THE CHOREOGRAPHY IN SYNCHRONIZATION "BEING TOGETHER."

**D. Costume**

A SINGLE SCORE PER ROUND WILL BE GIVEN BY EACH DANCE JUDGE THAT REFLECTS THE QUALITY AND DEGREE OF AUTHENTIC REPLICATION OF THE COSTUMES.

***E. Director Capability/Level of Difficulty***

THIS REFERS TO THE FACT THAT THE DIRECTOR'S KNOWLEDGE AND AMOUNT OF RESEARCH HE/SHE HAS CONDUCTED IN RELATION TO THE REGIONS PRESENTED IN THE DANCE PERFORMANCES, STRONGLY INFLUENCES THE QUALITY OF THE PERFORMANCE, REGARDLESS OF THE LEVEL OF THE DANCING ABILITIES OF THE INDIVIDUAL DANCERS. THE INTENT IS TO CRITIQUE AND PROVIDE FEEDBACK TO THE DIRECTOR REGARDING THEIR LEVEL OF KNOWLEDGE OF GREEK FOLK MUSIC AND DANCE AND THEIR ABILITY TO PRESENT THE MATERIAL, REWARDING THOSE DIRECTORS WHO ATTEMPT TO ACHIEVE NOVEL OR DIFFICULT MATERIAL OR CHOREOGRAPHY REGARDLESS OF THE SUCCESS OF THE PERFORMANCE ITSELF.
